### [Use of the Business Matching System]

In order to use the Business Matching System, please register after reading and accepting the User Agreement below.

## Article 1 (No Warranty)

- 1. JTB Communication Design, Inc. is responsible for maintaining and managing the facilities required for the services under this Agreement. Provided, however, that if a failure occurs for any reason in the course of the provision of the services, our sole responsibility at the time of such occurrence or in respect of any service interruption shall be to endeavor to overcome the failure as soon as possible.
- 2. In no case shall we be responsible in any way (i) for any damage suffered by users of the Business Matching System in connection with their use of the services, or (ii) for any damage caused by said users to third parties in connection with said use or for any liability pertaining to such third-party damage, whatever the cause may be.
- 3. Users of the Business Matching System agree that we do not provide any warranty as to benefits, outcomes, or other gains on their part.

### Article 2 (Period of Use of the Business Matching System)

1. The period of use of the Business Matching System shall be from the date of registration (the date of payment completion) through February 28th, 2025.

#### Article 3 (Termination by Us)

- If a user of the Business Matching System falls under any of the cases described in (1) through (3) below, we may, without any notice or demand, immediately (i) impose a temporary suspension of the services, or (ii) stop the services under this Agreement and require the termination of this Agreement:
  - (1) Where the user has committed any of the acts set forth in Article 4 (Prohibited Acts)
  - (2) Where the user has made a false statement
- 2. Notwithstanding the preceding Paragraph, if we find it difficult to keep this Agreement in effect, we may, upon written notice, require any user of the Business Matching System to terminate this Agreement.
- 3. Even where we have taken one of the measures set forth in the preceding two Paragraphs, thereby preventing the relevant user of the Business Matching System from using the services, with damage occurring as a result, we shall not be responsible for the damage.

#### Article 4 (Prohibited Acts)

- 1. Users of the Business Matching System shall not commit any of the following acts:
  - (1) Act of providing false registration details during the registration procedure
  - (2) Act that hinders the operation of the website concerned or the provision of the services, or act that may otherwise affect the services
  - (3) Act of making unauthorized use of any e-mail address or password

- (4) Act that causes, or is likely to cause, any inconvenience, disadvantage, or damage to other users of the Business Matching System, third parties, or us
- (5) Act that infringes, or is likely to infringe, on any trademark rights, copyrights, privacy rights, or other rights belonging to other users of the Business Matching System, third parties, or us
- (6) Act that is, or is likely to be, in violation of public order or morals, or otherwise in violation of laws or regulations
- (7) Any other act that we consider inappropriate
- If we consider that any information disclosed by any user of the Business Matching System to us or on the website concerned is improper, we may modify, edit, or delete such information.

Article 5 (Measure after the End of the Period of Use)

Even after the period of use of the Business Matching System ends, the provisions of Articles 1, 4, 6, 7, and 8 shall remain in effect.

Article 6 (Governing Law)

The formation, effect, performance, and construction of this Agreement shall be governed by the laws of Japan.

Article 7 (Consultation)

Any matter not provided for in this Agreement shall be settled through good-faith consultation between JTB Communication Design, Inc. and users of the Business Matching System.

Article 8 (Jurisdiction by Agreement)

With respect to any litigation related to this Agreement, the Tokyo District Court shall be the agreed court of first instance with exclusive jurisdiction.
